- Call to Order and Roll Call of Members Present: The meeting was called to order by Chairperson Jennie Mills (Shorewood-Troy Public Library District) at 1:31pm. Roll call was conducted. - 2. **Changes/Additions to the Agenda:** No changes, additions or corrections were noted.
- 3. **Minutes:** Paul Mills moved to approve the minutes of the June 16, 2023 Board Meeting and Lisa Pappas seconded. The motion was approved.
- 4. **Public Comment:** There was no public comment.
